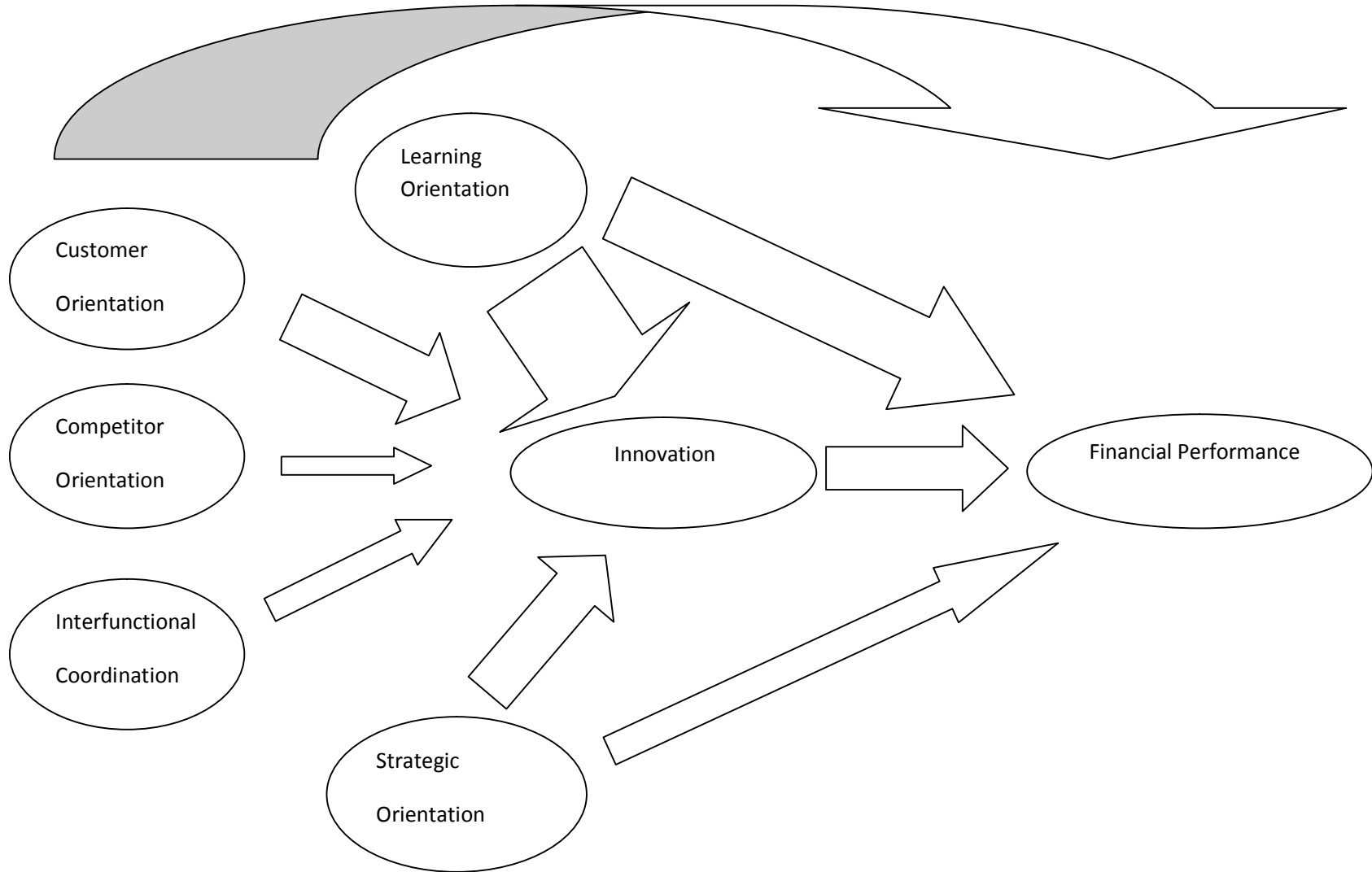


Fig 1. Impact of elements of market orientation and other factors upon financial performance in small firms with limited competition. Thickness of arrows represents size of effect.
